The following shall be added to Section II, Paragraph 17 – Traffic Impact Analysis:

- 17.1 The extension of Northline Drive, as depicted in the approved Traffic Impact Analysis, may be designated as a private access drive, subject to the following conditions:
 - The Owner shall provide an easement for the private access drive; and
 - 2) The private access drive shall be open to the public in perpetuity; and
 - 3) The access drive shall be designed to support fire apparatus and meet all other applicable regulations in accordance with the City Fire Code; and
 - 4) The Owner shall be responsible for the standards of construction and all maintenance of the access drive in perpetuity.
- 17.1 All terms and conditions stated in the Ingress and Egress Easement, attached hereto as Exhibit C of the Plan, are incorporated herein


