

ADMINISTRATIVE AMENDMENT TO PUD 86 - AMENDMENT NO. 5

WE, THE UNDERSIGNED, HEREBY ACKNOWLEDGE:

THAT, Planned Unit Development No. O-2014-1511 ("the Plan") was adopted by the City Council of the City of Round Rock on June 26, 2014; and

THAT, Section II, Paragraph 15.1 of the Plan provides for minor changes which do not substantively or adversely affect the Plan; and

THAT, Section II, Paragraph 15.1 of the Plan requires that such minor changes be approved in writing and be signed by the Director of Planning and Development Services and the City Attorney.

THEREFORE, we hereby approve the following administrative modification to Planned Unit Development (PUD) No. 86:

The following shall be added to Section 5.0 - Permitted Uses:

5.2. The term 'senior' shall mean persons 55 years of age or older. Senior housing is occupied solely by seniors or houses at least one person who is age 55 or older in at least 80 percent of the total number of residential units and adheres to a policy that demonstrates an intent to house persons who are 55 years of age or older.
