This rebate is for the purchase and installation of an approved water flow sensor. Water flow sensor devices record your water use and identify potential leaks in your system and alert you to unusual usage.

**ELIGIBILITY & GUIDELINES:**

- Applicant must be a direct City of Round Rock water customer in good standing. (MUD customers are not eligible)
- The property must have Wi-Fi for the device to work, and the device app must be installed on your mobile device. The user must agree to receive app notifications to be alerted of potential leaks.
- \*Only Buoy, Flo by MOEN, Flume, Phyn Plus, & StreamLabs Control flow sensors are eligible for the rebate.
- The City will confirm product installation with the vendor, as necessary, to confirm activation of the flow sensor.
- Installation of a flow sensor has no bearing on your water bill read dates or billed use amount. All water bills are based solely on the City installed water meter at the property.
- An itemized receipt(s), along with a picture of the installed device, must be submitted with the application within 60-days of purchase. Device must be installed at time of application.
- The City does not endorse specific brands or installers, nor is responsible for the performance or repair of device.
- Rebate amount is \$100 and limit one rebate per water account.
- Rebate check will be mailed 2-4 weeks after the application has been processed and approved.
