Surety Bond & Liability Insurance

Per Sec. 44-279 of the ROW Ordinance, \$5,000 **Surety Bond** paperwork will need to be filled out and filed annually with the City of Round Rock. This Surety Bond is in the amount of the estimated cost to restore the public rights-of-way for the work anticipated to be done in that year and to relocate facilities. This Surety Bond will be valid each year construction occurs through one full year after the completion of the construction from a Surety company authorized to do business in the State of Texas. We request that companies fill out our Permit Bond and reference their Surety Bond #. **Note that all Surety Bond documentation must be sent to the Transportation Administration at 3400 Sunrise Road, Round Rock, TX 78665 for record keeping.**

Additionally, Utility companies will need to obtain and maintain **Liability Insurance** coverage in the amount of \$1,000,000 with a company licensed to do business in the State of Texas with an AM Best rating of at least A-. Said insurance will need to be provided as proof of coverage at the time of request for any construction permits and prior to any commencement of work moving forward.
