THAT, Section II, Paragraph 11.1 of the Plan provides for minor changes which do not substantively or adversely affect the Plan; and

THAT, Section II, Paragraph 11.1 of the Plan requires that such minor changes be approved in writing and be signed by the Director of Planning and Development Services and the City Attorney.

THEREFORE, we hereby approve the following administrative modification to Planned Unit Development (PUD) No. 129:

The following shall be added to Section II, Paragraph 7 – Applicability of City Ordinances:

Add a new Sec. 7.10 to read: Parking structures may contain parking spaces designed and reserved for small or compact vehicles. Compact vehicle spaces shall not be smaller than 8 feet wide and 18 feet long. Compact vehicles spaces shall not exceed twenty percent (20%) of the total number of parking spaces in any parking structure and shall be identified by signage and/or markings within the compact parking space.
