ACTIVE SUPERVISION OF ALL CHILDREN REQUIRED:

Children 12 years and younger <u>require active supervision at all times</u>. Children 6 years of age and younger require a guardian <u>within arm's</u> <u>reach at all times</u> at all city pool facilities.

Active Supervision is providing close and constant attention to children you are supervising in and near the water. The role of an actively Supervising Adult differs from that of a lifeguard. The Adult's role is to watch and prevent emergencies. A lifeguard is trained to rescue in the event of an emergency.

Lifeguards are an important safety feature, but they are not intended to replace the close supervision of guardians and / or caregivers.

ADDITIONAL INFORMATION

ADMISSION FEES:

Cash or Visa / Master Card ONLY. NO CHECKS will be accepted at the pools. Arrangements can be made for check payments to be accepted at the main Parks & Recreation Office on a case-by-case basis.

Example: Camp ABC wants to go to all three (3) City of Round Rock pools this summer. This camp will need to submit 3 separate Reservation Forms.

Each reservation will be made on a **first come**, **first serve basis**. When arriving at any of our pools, please have a chaperone/counselor check in at the front gate. A management team member will have a safety talk with your group before entry into our pools takes place.

Swim Attire Guidelines: All swimmers and non-swimmers must wear a swimsuit. Swimsuits are designed to be worn in the water without falling off or becoming transparent. Additional clothing, such as a t-shirt, may be worn **in addition** to a swimsuit to provide additional sun protection and/or for modesty purposes, provided it does not impede swimming.

Cut-Offs, "thong bikinis, clothing with exposed zippers, rivets, buckles, or any metal ornamentation are Not
Allowed. Athletic shorts worn over underwear are NOT considered proper attire.

Public Health: Due to public health concerns and to reduce the chance of fecal contamination, please do not bring ill children to the pool. Additionally, <u>please plan regular bathroom breaks for your swimmers</u>.

Life Jackets: Only US Coast Guard approved Life Jackets are permitted in RR Pools. Limited quantities of USCG approved Life Jackets are available at all City of Round Rock pools free of charge during your visit on a first come, first served basis. Water Wings, swimsuits with built in flotation, and life jackets not approved by USCG are **Not** Allowed.

NEW ~ Texas House Bill 59, Cati's Act – Effective September 1, 2023

H.B. 59 amends the Health and Safety Code to require an organization, including **a day camp**, **youth camp**, **school**, **preschool**, **kindergarten**, **nursery school**, **child-care facility**, or any other facility providing child-care services licensed by the Health and Human Services Commission (HHSC) that authorizes a child younger than 12 years of age to engage in an organized water activity in which participants will enter or travel on a body of water, other than a wading pool with a maximum water depth of not more than 18 inches, to do the following:

 \cdot Require the child's parent or legal guardian to affirm in writing whether the child is able to swim or is at risk of injury or death when swimming or otherwise accessing a body of water; and

• Provide each child who is unable to swim or is at risk of injury or death when swimming or otherwise entering a body of water with a properly fitted and fastened Type I, II, or III U.S. Coast Guard approved personal flotation device or an equivalent device, as determined by the executive commissioner of HHSC, and ensure the child is wearing the device and that it is properly fitted and fastened for the child.

*The City of Round Rock is NOT required to provide a child with a flotation device. It is the responsibility of the child care provider / group organizer. The role of a ACITVELY SUPERVISING ADULT differs from that of a lifeguard. The Adult's role is to watch and PREVENT emergencies. A lifeguard is trained to rescue in the event of an emergency.

Teach children who cannot swim to stay away from water unless accompanied by a qualified adult. A qualified adult knows how to swim, stays within arm's reach of the child, and maintains eye to eye contact with the child.
