Better Bathroom Rebate Guidelines

This rebate is for the purchase and installation of WaterSense Certified toilets, showerheads, bathroom faucets, and faucet aerators. Replacing older toilets with water-efficient toilets can save 4,000 gallons of water per toilet per year. Updating showerheads can save up to 2,700 gallons of water per year, and water-efficient faucets and aerators can save up to 700 gallons per year!

PROGRAM GUIDELINES

ELIGIBILITY:

- Applicant must be a direct City of Round Rock water customer in good standing.
- Application will be denied if the property has participated in past City of Round Rock bathroom rebate programs and has reached the maximum number of fixtures replaced. *For example: home has two bathrooms and rebates for two toilets were already granted. The resident can apply for showerheads and bathroom faucets, but not toilets.*
- The application, Itemized receipt(s), and photo of installed fixture must be submitted within 90 days of purchase date. Receipt(s) must include the purchase date, vendor name, fixture price, and brand or description of item purchased.
- Incomplete applications will be denied.
- The city may end this program at any time, without warning. Please check the website for program updates.

FIXTURE REQUIREMENTS:

- New toilets, showerheads, and bathroom faucets or faucet aerators **must** be EPA WaterSense* Certified. Find products at lookforwatersense.epa.gov/products (**Please ensure product is on EPA list, we have seen products mislabeled.*)
- The City does not endorse specific brands, nor is responsible for the performance or repair of new fixture(s).
- Applicant is responsible for disposal of old fixture(s). Per state law, old, used toilets cannot be sold or donated.



REBATE DETAILS:

- Fixture rebate is 50% of the cost of the new toilet, showerhead, and bath faucet.
- Installation cost is rebated at 50%, *up to a maximum of \$50 per fixture*. Invoice or receipt from the installer is required. An estimate from an installer will not be accepted.
- Sales tax and delivery/shipping costs are not included as part of the rebate.
- Toilet seats, bathtub faucets, and kitchen faucets are not eligible for the rebate.
- Maximum rebate disbursement is \$600 per water account per year. You may apply multiple times per year, until the maximum amount is reached.
- Number of toilets, showerheads, and faucets rebated may not exceed the number of existing bathrooms at the property. This is for the replacement of old fixtures; new home additions are not eligible.

APPLICATION PROCEDURE:

1. Read the Program Guidelines on page 1 to ensure eligibility.
2. Submit application and itemized receipt(s) within 90 days of fixture purchase date.
3. No pre-inspection is necessary; however, you may be contacted for a final inspection.
4. A rebate check will be mailed 2-4 weeks after the application has been processed and approved.
