
Project Timeline

Early 2025: Construction anticipated to begin


Project Funding

Chisholm Trail South Improvements

Improvements to Chisholm Trail Road will include:

- Full depth pavement reconstruction from Sam Bass Road to Sunset Drive
- Constructing a storm drain with curb inlets from Sam Bass Road to Sunset Drive
- Upgrading the waterline between Sam Bass Road and Sunset Drive
- Widening sidewalks to comply with ADA requirements
- Updating parallel parking between Sam Bass Road and Sunset Drive
- Adding a left-turn lane at Sunset Drive
- Resurfacing pavement from Brushy Creek to RM 620
- Installing decorative lighting



Detour Information - Sam Bass Rd. to Poker Alley

- Chisholm Trail will be reduced to one northbound lane between Sam Bass Rd. and Poker Alley, and a detour will be available for southbound traffic
- Properties will be asked to utilize Galloping Road or the I-35 Frontage Road for alternative access. Access will remain for properties with a single access point throughout construction.



Detour Information - Poker Alley to Emmanuel St.

- Chisholm Trail will be reduced to one northbound lane between Poker Alley and Emmanuel St., and a detour will be available for southbound traffic
- Properties will be asked to utilize Galloping Road or the I-35 Frontage Road for alternative access. Access will remain for properties with a single access point throughout construction.



Detour Information - Emmanuel St. to Sunset Dr.

- Chisholm Trail will be reduced to one northbound lane between Emmanuel St. and Sunset Dr., and a detour will be available for southbound traffic
- Properties will be asked to utilize Galloping Road or the I-35 Frontage Road for alternative access. Access will remain for properties with a single access point throughout construction.



Detour Information - Chisholm Trail at Sunset Dr.

- Chisholm Trail will be reduced to one northbound lane at Sunset Dr., and a detour will be available for southbound traffic
- Properties will be asked to utilize the I-35 Frontage Road and RM 620 for alternative access. Access will remain for properties with a single access point throughout construction.



Detour Information - Chisholm Trail

- Chisholm Trail south of Brushy Creek will be closed to traffic during daytime working hours and reopened during non-working hours
- Closures will occur in two segments to reduce traffic disruptions
- Access shall be coordinated and made available for properties with a single access point on Chisholm Trail
