This program’s goal is to boost lawn health. Caring for your lawn, starting with the soil, reduces water usage by increasing water holding capacity, promoting deep root growth, and reducing water runoff; all which help make it more drought tolerant.

**PROGRAM GUIDELINES:**

- Applicant must be a direct City of Round Rock water customer in good standing.
- Property must have **both services** (core aeration & compost application) completed on lawn’s turfgrass areas. Services do not have to be performed by the same company or service provider, or and can be completed by homeowner.
- Lawn aeration **MUST** be core aeration, not liquid aeration application, and may be performed by a professional or by renting aeration equipment and doing it yourself. *Core aeration consists of pulling soil plugs out of the ground, not simply poking holes in the ground.*
- Compost should be applied at a maximum depth of ½-inch over the entire grass portions of the lawn. Compost consists of natural materials, such as manure, chicken litter, green waste (lawn trimmings) and organic matter. *Mulch, rocks, topsoil, and chemical fertilizers are not compost, so not eligible.*
- Application and itemized receipt(s) with date and service provider name must be submitted within 90-days of service.
- Rebate amount is a flat amount of \$150 for residential properties and \$300 for non-residential properties.
- Rebate check will be mailed 2-4 weeks after application has been processed and approved.
- Rebates are available until funds have been expended; programs may end at any time, without notice.
